Charming guest house with 14 accommodation units and a restaurant by the sea in Sukošan, 7 km from Zadar, right by the sea, on the 1st line.

Sukušan has a long coastline with numerous bays, beautiful beaches and clear sea. It has a rich gastronomic offer and many cultural and entertainment facilities, which makes it a very desirable tourist destination. Thanks to the largest marina on the Adriatic, D-Marin Marina Dalmacija, it is a true paradise for sailors.

The pension is located next to a pine forest at the exit of the town, in the immediate vicinity of the beach and all facilities necessary for a pleasant stay.

It is located on a plot of land of 1474 m2.

On the plot there is a main house with an area of 889 m2 and an auxiliary building of 117 m2 in which there is a garage, a laundry room, a storage room and an auxiliary kitchen.

The main house consists of a basement, ground floor, first floor and attic.

In the basement, there is a wine cellar, a technical room for central heating and a storage room.

The ground floor of 357 m2 has a restaurant, terrace, toilet, corridor, room and kitchen.

On the first floor, with a total area of 255 m2, there are 1 studio apartment, 3 one-bedroom apartments and 3 rooms with bathrooms.

In the attic of 209 m2, there are 6 more bedrooms, 3 bathrooms, living room and kitchen, and a terrace.

There are about 150 seats in the restaurant and another 50 on the terrace.

The house offers a wonderful view of the sea.

Inside the spacious, beautifully landscaped yard, there is a garden with a terrace for sunbathing and a barbecue area for all-day enjoyment, as well as parking for 12 cars.

The boarding house is fully furnished and equipped for hospitality activities and represents an already wellestablished business.

An attractive location in a developed tourist destination ensures the return of invested funds, and this property represents a safe investment in tourism.
